

## Withdrawal from Bloomsburg University of PA Refund/Reduction of Charges Policy

The rates below only apply to a full withdrawal from the university. Partial withdrawals are not eligible for any change in charges after the add/drop period. Total tuition and tuition fee charges billed will be refunded (reduced) at the following rates; the difference will be the student's responsibility. **A portion of, or all of, a student's financial aid may need to be returned to the specific aid program, based on the withdrawal date entered in MyHusky, as the financial aid has not been fully earned.** Financial aid refunds issued to the student or parent may need to be returned. The amount due will then become the responsibility of the student. We strongly urge students who receive any financial aid and/or who are considering a withdrawal from the university to speak to the Financial Aid Office/Bursar Office to confirm the implications of a withdrawal on their student account.

\*Technology fee is non-refundable after 100% refund period.

\*\*After 100% refund period all classes must be dropped/withdrawn for any adjustment.

\*\*\***Please note:** If you are enrolled in a combination of Regular Session 1 and 7-week sessions (Sessions 2 and/or 3), that 7-week session classes must be dropped during the respective 7-week sessions 100% add/drop period to receive any refund during regular session. **Any session 2 classes dropped after 8/20/2020 or session 3 classes dropped after 10/10/2020 will not receive any refund if you are also enrolled in regular session 1 classes.**
