You must be tested in the state where you are a resident. - When they arrive for their appointment, patients are required to stay in their cars and go to the CVS Pharmacy drive-thru window to complete their test. No testing takes place inside the CVS Pharmacy, MinuteClinic or CVS HealthHUB location.
- Testing is supervised by a local MinuteClinic provider, and CVS Pharmacy team members oversee the collection of specimens at the drive-thru window.
- Specimens are sent to independent, third-party labs for processing. (2-3 days)

### Prior to Visiting

Please note that MedExpress only bills patients for the evaluation and treatment they receive from our medical providers during their visit. Unfortunately, we are not able to provide any information about how our commercial lab partner, LabCorp, will bill patients for COVID-19 testing, nor are we able to provide information about how specific insurance carriers will process claims related to COVID-19 testing and treatment.

### **3) Evangelical Community Hospital**

Evangelical Community Hospital's COVID-19 Alternative Testing Site will be opening at its new location on Monday, November 2, 2020. Operating from 9 am-6 pm, Monday through Friday, testing will be completed at 1499 St. Mary Street, Lewisburg, the corner of St. Mary and 15th streets, near the Central Susquehanna LPN Center.

Individuals should first call their primary care provider to share any symptoms or concerns related to COVID-19. The physician can then determine if testing is warranted and refer to the testing site.

The new test site is a drive-through location to maximize safety. Patients will be directed to drive around the building and enter through a garage door. Staying in the car, patients will be asked a series of questions and receive any tests ordered. They will then exit, driving out another garage door on the opposite side of the building.

The location change was made to have a more fixed location with proper utilities during the winter months when weather can be unpredictable.
